



Photography Waiver and Release of Liability Assumption of Risk and Indemnity Agreement

THIS FORM IS TO BE SIGNED AND TURNED IN AT CHECK-IN FOR ALL PHOTOGRAPHY SESSIONS

Welcome to the Missouri State Penitentiary. This property is now 180 years old and was decommissioned in 2004. While historic sites are fascinating, they can pose dangers to visitors; therefore, every visitor is required to sign this waiver prior to entering.

- This attraction reserves the right to refuse admission to anyone.
- You may experience low visibility, damp, moldy or wet conditions, uneven ground and stairs and extreme temperatures.
- You should NOT ENTER if you suffer from asthma, heart conditions, prone to seizures, physical ailments or any type of condition that prohibits you from walking or standing.
- DO NOT ENTER this attraction if you are intoxicated, wearing any form of cast, medical brace, using crutches or a wheelchair or have any type of physical limitations.
- DO NOT smoke, eat or run on the property.
- **No one under the age of 10 is allowed.**

Your ticket is a revocable license and may be taken and admission refused. Holder of this ticket understands that there is inherent risk involved with attending this attraction. Holder voluntarily assumes all risks and dangers associated with participation in this attraction. In consideration and acceptance of entrance into this attraction, holder agrees to indemnify and hold harmless the Jefferson City Convention and Visitors Bureau, Inc., the Discover Jefferson City Foundation, Inc., the State of Missouri, Missouri State Penitentiary Redevelopment Commission and/or the City of Jefferson, and their employees and agents, against any claims for incidents, occurrences, exposures or injuries encountered during time spent on the Missouri State Penitentiary property.

THIS AGREEMENT is made by and between The Jefferson City Convention and Visitors Bureau and Photographer named below.

WITNESSETH:

WHEREAS, Photographer wants to participate in taking photographs of the Missouri State Penitentiary, 115 Lafayette Street, Jefferson City, Missouri 65101, and,

WHEREAS, the Jefferson City Convention and Visitors Bureau agrees to grant the Photographer the right to take photographs of the buildings and grounds.

NOW THEREFORE, IT IS AGREED:

1. The Photographer acknowledges receipt of the Guidelines and Photography/Videography Agreement and agrees to comply with the terms and conditions.
2. As a condition of attendance, the Photographer assumes the risk of injury to person or property resulting from his/her use of the premises and does hereby release the Jefferson City Convention and Visitors Bureau, Inc., the Discover Jefferson City Foundation, Inc., the State of Missouri, Missouri State Penitentiary Redevelopment Commission and/or the City of Jefferson, its trustees, employees, agents and successors from and against any claim, demand or liability arising out of such injury and will protect and indemnify the Jefferson City Convention and Visitors Bureau, Inc., the Discover Jefferson City Foundation, Inc., the State of Missouri, Missouri State Penitentiary Redevelopment Commission and/or the City of Jefferson and those persons released with respect to any claim, demand or liability arising out of such injury.
3. The Photographer shall be held responsible for any damages to the grounds or building incurred resulting from the use of backdrops or other props used in photographic sessions. The Photographer shall pay a fee equal to the estimated cost of the damages as determined and approved by the Jefferson City Convention and Visitors Bureau.
4. The Photographer agrees to refrain from crossing, entering or using any building space that is marked with signs, chains, tape or other types of barricades.
5. There can be no nudity, semi-nudity, or sexually explicit images shot at the Missouri State Penitentiary.
6. If the Photographer fails to abide by the obligations of this Agreement, the Jefferson City Convention and Visitors Bureau shall have the option to immediately cancel this Agreement providing verbal notice to Photographer.
7. The Jefferson City Convention and Visitors Bureau, Inc., the Discover Jefferson City Foundation Inc., the State of Missouri, Missouri State Penitentiary Redevelopment Commission and/or the City of Jefferson make no guarantees or warranties with respect to any photography. In no event shall the Jefferson City Convention and Visitors Bureau, Inc., the State of Missouri,

Missouri State Penitentiary Redevelopment Commission and/or the City of Jefferson be liable for direct, indirect, special, incidental or consequential damages which are in any way related to the photography.

8. This Agreement contains the entire agreement of the parties and there are no other promises or conditions in any other Agreement whether oral or written.
9. Photographers, participants, talent, crew and models must be accompanied by a Jefferson City Convention and Visitors Bureau staff member at all time and will not be allowed to roam the facility freely.
10. The Jefferson City Convention and Visitors Bureau retains the right to immediately remove anyone from the premises who does not follow the terms and conditions contained above or with the terms and conditions set forth in the Photography/Videography Agreement.
11. The failure of either party to enforce any provision of the Agreement shall not be construed as a waiver or limitation of that party's right to subsequently enforce and compel strict compliance with every provision in this Agreement.

The fees for the Photography Tours are as follows:

3-Hour Photography Session -- \$40/person (minimum of 4 people required – or pay for 4) = \$160.00
5-Hour Photography Session -- \$60/person (minimum of 4 people required – or pay for 4) = \$240.00

Fees for Photography Tours are due upon making reservation – only refundable with min. 48 hour prior notice of cancellation.
